## Integra Announces Health-Oriented Mixed-Use Development for Aventura

Miami-based Integra Investments recently announced plans for Aventura ParkSquare, a mixed-use development engineered with healthy living and wellness in mind.

Zyscovich Architects is in charge of the design. The company is behind projects such as Bayfront Park and the Lincoln Road Cinema & Retail Complex. The property will be the first of its kind in the suburban city,



intended to serve as an important gathering place for social interaction while offering an array of health-oriented features.

Located on the corner of 2900 Waterways Boulevard and Northeast 207th Street, the nearly 7.5-acre Aventura ParkSquare site is just minutes from Aventura Mall and Gulfstream Park, as well as Biscayne Boulevard and I-95 with direct access to Miami and Fort Lauderdale.

Plans call for a residential tower with 131 units, a senior living facility, a 100,000-square-foot Class-A office building with outdoor event space and 55,000 square feet of retail space for restaurants and shops. The residential units range from 1,000 to 1,800 square feet and will sell for between \$400,000 and \$800,000. The design also includes a hotel, a public park and a 45,000-square-foot wellness medical center for specialty healthcare businesses.

As healthy living is the focal point of the development, 15-foot sidewalks are included in the design for enhanced walkability, and curbs and other obstructions will be eliminated in order to encourage jogging. The buildings will feature open staircases that support physical activity and less use of elevators. The developers expect to break ground in Q1 2015, and the project is slated for completion in early 2017.

## September 3, 2015 Aventura ParkSquare Gets Lofty Hotel Centerpiece

Miami-Dade County's massive Aventura ParkSquare mixed-use development is getting a brand

new Aloft hotel in 2017. Integra Investments announced that the new 207-key asset will serve as the development's signature hotel component. Construction on the Aloft Hotel at Aventura ParkSquare is expected to start this fall and be completed in the spring of 2017. Developed by Lebanon, N.H.-based Norwich Partners and designed by Zyscovich Architects, the hotel will be located directly across the street from the nearly 7.5-acre development at the corner of Northeast 207<sup>th</sup> Street and 2900 Waterways Blvd.

Upon completion in early 2017, Aventura ParkSquare will incorporate: 55,000 square feet of retail; a 100,000-square-foot Class A office building; a 131-unit luxury condominium tower; and a 45,000-square-foot wellness medical center. The property is strategically located close to Biscayne Boulevard and the I-95, providing direct access to the cities of Miami and Fort Lauderdale.
